

1. Agreement: These rules govern the **Street Food Market giveaway** (the “Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Sponsor, which decisions shall be final and binding upon all entrants.

2. Sponsor: The Contest sponsor is Evergreen, a not for profit that inspires action to green cities (the “Sponsor”). The Contest prize is supplied by Evergreen Brick Works (the “Prize Supplier”).

3. Eligibility: This Contest is open to residents of Ontario who have reached the age of 19 except for employees, their immediate families and anyone living with any employee of the Sponsor, the Prize Supplier or either of their respective corporate affiliates, advertising or promotional agencies. Limit of one entry per household. Multiple entries by the same person or household using one or more e-mail accounts will result in disqualification. Incomplete email, name and address information will not be accepted and will be disqualified.

4. Contest: To enter the Contest, come to the Street Food Market at Evergreen Brick Works’ Winter Village and take a photo of a vendor’s food offering. Share this image via social media channels with the #WinterVillageTO hashtag. The **Contest Period begins at 7:00am ET on January 28, 2017 and ends at 6:00pm ET on February 20, 2017 with a winner being drawn on Jan. 30, Feb. 6, Feb. 13, Feb. 20, respectively.** The selected entrant(s) will be chosen by random draw, which will take place following the Contest Period. Each selected entrant will be contacted on social media by a representative of the Sponsor, and must reply within 48 hours to maintain eligibility. If a selected entrant cannot be contacted within this time period or fails to respond to any attempted contact, such selected entrant will be disqualified, his/her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.

5. Prize: Four (4) prizes are available to be won, consisting of one voucher to the Street Food Market at Evergreen’s Winter Village (retail value of \$50.00 CDN). Transportation to and from the market is not covered as part of this prize package. All required documentation and information regarding the issuance and delivery of the prize will be sent via social media directly to each selected entrant’s social media accounts. Each prize will be available for pick-up at Evergreen’s Winter Village. If a selected entrant does not sign the confirmation and release form described below and claim his/her prize within 48 hours of notification, or does not or cannot accept prize delivery on the terms and within the delivery times required by Sponsor, the next eligible entry selected by random draw may be contacted and the first selected entrant will have no further claim to the prize. The prize-winner and any guest(s) are solely responsible for any expenses not listed above. No responsibility is assumed by the Sponsor for cancelled, delayed, suspended or rescheduled events for any reason whatsoever beyond its control. If a selected entrant is unable or unwilling to accept or otherwise redeem the prize on the terms it is awarded, the prize shall be forfeited and no refunds, cash or substitutes will

be provided in whole or in part. Sponsor is not responsible for unclaimed prizes. Sponsor shall not be responsible for any postal or courier delays or any loss, theft or damage that may occur to any prize. Any unused portion of the prize will be deemed to be forfeited and no substitution or other compensation will be awarded.

6. Release: By act of entering the Contest, each entrant releases and discharges the Released Parties (defined below) from any and all claims or liability arising out of or relating to his or her participation in this Contest or claim to, acceptance or use of any prize. In addition, prior to receiving the prize, each selected entrant will be required to show valid photo ID and to sign a confirmation and release form releasing the Sponsor and the Prize Supplier and each of Sponsor's and the Prize Supplier's respective related parties and its respective affiliates, successors, assigns, past and present employees, officers, directors, shareholders, agents, representatives, and media buying, advertising and/or promotional agencies (collectively, the "**Released Parties**") from any and all liability in connection with the Contest and/or the acceptance or use of any prize, confirming compliance with the rules and consenting to the use of his or her name and photograph, without further compensation, in any publicity carried out by the Sponsor, the Prize Supplier or their respective advertising and promotional agencies. The signed confirmation and release form must be received by Sponsor within 48 hours of notification, or the prize may be forfeited and awarded to an alternate entrant.

7. Privacy: The Evergreen Website is intended to serve as a tool to inform supporters, friends and donors about Evergreen, its programs, and other conservation issues, and to provide the means for schools, communities and individuals to take action to help leave our children a living planet.

In the course of providing this online service, information is exchanged back and forth between the Evergreen servers, online users, and their browsers. In some instances on this site, you may be asked to list your name, e-mail address, and other information. Our policy with regards to your personal information is listed below. Evergreen believes that your personal information deserves utmost protection. Evergreen reserves the right to remove any submissions that are deemed to be offensive, illegal, off-topic or inappropriate in any way. 8. Banning: The Sponsor may, in its sole discretion, prohibit any person from entering the Contest whom it believes to be abusing the Contest rules or otherwise seeking to

undermine the Contest's operation. Such abuse includes, without limitation, entering false information, entering more than once, and engaging in threatening, abusive or otherwise inappropriate behavior towards other contest entrants or Sponsor's or Prize Supplier's employees. Any attempt by an entrant or other individual to deliberately damage any website or undermine the legitimate operation of this Contest, including but not limited to any fraudulent claims, may be a violation of criminal and civil laws. Should any such attempt be made, Sponsor reserves the right to seek remedies and damages from any such individual, to the fullest extent permitted by law, including criminal prosecution. Any entrant who Sponsor believes to be engaging in any of the foregoing activities will forfeit any prize(s) won, and may, in Sponsor's sole discretion, be disqualified from this Contest and any and all of Sponsor's future contests.

9. Other: Odds of winning depend on the number of eligible entries received. This Contest is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. The Sponsor reserves the right to cancel or modify the Contest or the Contest rules at any time without notice. All prizes must be accepted as awarded, are non-transferable and are not convertible to cash. The Sponsor reserves the right to substitute any prize or portion of the prize with a prize of equal or greater value. Prizes are awarded as-is and no warranties or guarantees are implied or expressed. Sponsor is not liable for any lost, late, or misdirected entries or inability to process entries online, and none of the Released Parties shall be liable for any errors, injury, damage or negligence that may arise in connection with this Contest or any prize, including without limitation technical failures of any website or software, viruses, website disruptions, malfunctions or website down-time, or any human error, bodily injury, death or property damage incurred or suffered by any Contest entrant or third party. The use of any automated system including robotic or form filling software to enter or participate in this Contest is prohibited and will result in disqualification of all entries by anyone using such assistance.
